2. Exclusive Photographer. The Photographer shall be the exclusive photographer retained by the Client for the purpose of photographing the wedding. Family and friends of the Client shall be permitted to photograph the wedding as long as they shall not interfere with the Photographer's duties and do not photograph poses arranged by the Photographer.

3. Deposit and Payment. The Client shall make a deposit to retain the Photographer to perform the services specified. With packages, a deposit of \$100.00 is due at signing of this contract, with ½ to be paid four weeks prior to wedding and the remainder to be paid two week before the wedding. Upon signature, photographer Shelly Hyde reserves the time and date agreed upon, and will not make other reservations for that time and date. For this reason, the \$100.00 deposit is non-refundable.

4. Cancellation. If the Client shall cancel this Agreement thirty (30) or more calendar days before the wedding date, any payment other than the \$100.00 deposit paid to the photographer shall be refunded in full.

5. Copyright and Reproductions. The Photographer shall own the copyright in all images created and shall have the exclusive right to make reproductions. The Photographer shall only make reproductions for the Client or for the Photographer's portfolio, samples, self-promotions, entry in photographic contests or art exhibitions, editorial use, or for display within or on the outside of the Photographer's studio. If the Photographer desires to make other uses, the Photographer shall not do so without first obtaining the written permission of the Client.

6. Client's Usage. The Client is obtaining prints for personal use only, and shall not sell said prints or authorize any reproductions thereof by parties other than the Photographer. If Client is obtaining a print for newspaper announcement of the wedding, Photographer authorizes Client to reproduce the print in this manner.

All terms of this agreement are understood and agreed upon.
